We utilize volunteers to provide a wide range of services, including Age In Place services, Health and Wellness, Personal Growth and Education, Resource Distribution, and Recreation and Socialization programs. In 2023, we served more than 1,700 seniors, delivering 10,932 instances of service, including driving 22,000 miles to take seniors to critical doctor appointments and errands.
